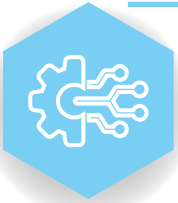
EDUCATION & WORKFORCE

ECONOMIC DEVELOPMENT & INFRASTRUCTURE

- Work to preserve Texas' business-friendly climate by supporting policies and robust incentive programs that promote investment and job creation for Texans.
- Support a tax system that stimulates economic growth, balances the interests of all Texans, and provides transparent rules and processes.
- Support additional investment in long-term planning for water availability to meet the state's future needs.
- Protect Texas' reliable, affordable, competitive, and diverse energy market and pursue opportunities to enhance grid resiliency and reliability.
- Support continued funding for all modes of transportation for our rapidly growing state.
- Support policies that incentivize broadband infrastructure projects to connect Texans.



EDUCATION & WORKFORCE

- Help ensure a rigorous PK-12 education system through enhanced per-student funding, investment in evidence-based strategies, and a sustained commitment to academic assessments and accountability.
- Improve access to quality child care through incentives for employer child care benefits and systemic support for Texas' child care infrastructure to reduce barriers to workforce participation.
- Facilitate pathways to living-wage careers through state support for skills-training programs in high-demand and emerging fields—including high-tech jobs—and alignment between education and workforce systems.
- Maintain the competitiveness of Texas' higher education institutions through state investment in capital construction projects, research initiatives, and workforce development programs.



HEALTH CARE

- Support efforts to increase adequate, accessible, and affordable health care coverage to promote the health and well-being of Texas businesses and their employees.
- Support initiatives to mitigate workforce barriers and encourage high retention rates.
- Support improvement of the mental and behavioral health care processes to ensure timely access to services.
- Continue to support adequate, predictable, and stable investments in health care providers, employers, and innovators to nurture the growing population in Texas.
- Preserve employer flexibility for employee benefit health plans in Texas.
- Establish a state incentive program tailored to biotech and life sciences companies.



TECH POLICY

- Promote reasonable regulatory frameworks for emerging technologies that drive innovation, investment, and job growth.
- Pursue a measured approach to regulating AI that promotes interoperability and responsible development and deployment while narrowly targeting high-risk applications.
- Help ensure the growth of the tech industry is supported by the necessary infrastructure.

- Continue to support efforts that promote public safety initiatives that help build greater trust between communities and those serving in law enforcement.
